CORPORATION BOARD REPORT | Summer '07

The spring meeting of the Corporation Board was held on April 28th in conjunction with the Dad's Day golf outing and barbecue dinner. Several board members joined in both the golf and the evening festivities.

The Board received very affirming reports on the condition and operation of the active Chapter from the grand master and concerning rush for next fall. The prediction is that 45 - 50 actives will be returning to the chapter house, and a pledge class of 25 is easily within current reach. This will ensure a "full" house and continued financial stability for both the active Chapter and the House Corporation. Alumni Annual Fund giving appears to be on the rebound with most donations being marked for the Educational Foundation as suggested.

This is a gratifying response to the Chapter's turnaround following the sanctions episode. Please keep it coming.

Chapter rent paid to the Corporation was continued at the current rate. Nevertheless, the annual house bill was raised to \$7,000. This was necessitated by constantly rising operational costs. Our fees remain competitive with both University housing rates and comparable fraternity housing at KU.

The Board reviewed nominations and selected three alumni (**Chase '55**, **Wolfe '61**, and **Mackenzie '66**) for induction into

the Chapter Hall of Fame at Homecoming this November. Immediate Past Grand Master Cory Sims '04 was selected as Chapter Man-of-the-Year for 2006 - 2007 and will receive his MOY award plaque at Homecoming.

Brother Alan Mulally '64, CEO of Ford Motor Co., will be nominated for the national Kappa Sigma Man-of-the-Year award for 2007 by the undergraduate Chapter. The Board unanimously approved this ambitious undertaking and agreed to participate in organizing and sponsoring the national award banquet when Brother Mulally is selected. We are anticipating a great winter event.

As promised, your current board president will step down at the conclusion of the pres-

ent term in November. Accordingly, a nominating committee consisting of Brothers Jim Wright '57, Tom Robinett '69, and Andrew Klein '95 have been tasked with presenting a new slate of officers for election. It is my view that this is a good time to change the Board chair as the active Chapter is in very strong hands, Alumnus Advisor Billy Brandtonies '02 is staying on, there is an active Parents' Club again, and both the cook and housemother have signed on for another year. We have had a good first year with the property maintenance management contractor and the prospects for a full house this fall are very good indeed. Absent an unexpected disaster between now and November,

Our goals for next year are quite simple: instead of merely competing in activities and events, we plan on winning them. We hope to continue restoring the pride that all brothers of Gamma-Omicron have in being the best fraternity around.



It is my honor to announce the 2006 - 2007 Gamma-Omicron Man-of-the-Year as Cory Sims '04. Cory is an active member in the Gamma-Omicron Chapter, a leader in the community, and a respected student at the University of Kansas. He is an exemplary leader.

Academically, Brother Sims has excelled at the University of Kansas. As a junior in the KU William Allen White School of Journalism, he has repeatedly demonstrated his ability to obtain high marks in upper-level courses while striving to obtain a degree in strategic communications. In addition to exemplifying the attributes of a dedicated student, Cory has repeatedly assisted in helping his fellow students and brothers with their coursework. As grand master of Gamma-Omicron, Cory frequently emphasized the importance of scholarship and good study skills, and was responsible for many improvements in Gamma-Omicron's scholarship program. His efforts are evident in Gamma-Omicron's overall progress in the grade standings measured against fellow fraternities at KU.

Brother Sims answered the call when Gamma-Omicron needed him to step up and assume the mantle of a chapter leader. His fortitude in this capacity is not equaled by any other member of this fraternity. As a member of this house, Cory has officially served as grand master, grand procurator, rush chair, pledge educator, philanthropy chair, and pledge class treasurer. His list of positions is not only impressive in its emphasis on management, but considering his work in unofficial positions, his accomplishments are even more praiseworthy. As grand master of Gamma-Omicron and to this day, Cory has assisted in almost every position that exists and managed to create new positions where leadership was lacking. He is responsible for facilitating Gamma-Omicron's first annual Halloween philanthropy with Alpha Chi Omega, establishing new rules and guidelines for scholarship, instituting a revolutionized pledge program, recruiting the majority of recent formal and informal pledges, creating and fulfilling the duties for a public relations chair, prepar-

A few words in this article can never fully convey the countless hours that he spent in assuring our removal from trusteeship.

In addition, his efforts and leadership motivated the Chapter and inspired all of its members to become better individuals and better leaders themselves in a communal effort to regain Gamma-Omicron's good name. Cory chose to make tough decisions and enforce new standards and paid unfortunate costs for doing the right thing. He lost friends and burned bridges with many people by maintaining resolve in fulfilling all of the tenets of the trusteeship process. While the Chapter as a whole won out, I know that Cory experienced many troubles in attaining that end.

There is no question that Cory Sims is a leader in this house, and he has repeatedly embodied the qualities that we all should strive for as members of this chapter.
