#### HALL OF FAME INDUCTEE

### Tom Robinett '69

Brother Tom Robinett from Leawood, KS was initiated into Kappa Sigma in 1969. He graduated with a B.S. in Secondary Education in 1971 from University of Kansas and J.D. in 1983.

Robinett served as the Grand Master of Ceremonies, Grand Scribe and IFC Representative during his undergraduate years.



While at University of Kansas, not only was he involved in leadership roles within Kappa Sigma but he also was on the Track and Field and Rugby teams.

Tom Robinett has worked with many companies through the years including American Academy of Family Physicians as General Counsel; Applebee's International as Associate General Counsel; and lastly Lewis, Rice & Fingersh as a partner. Today, he is the Vice President of Public Policy and Advocacy for Overland Park Chamber of Commerce

Tom is widely involved in his community and is recognized for his many leadership roles. He currently serves on the Board of Trustees of Menorah Medical Center and was the Past Chair. He serves on the Board of Directors of United Community Services of Johnson County which includes serving on the Executive Committee and as Chair of the Public Policy Committee. He serves on the City of Overland Park Planning Commission as chair. He is on the advisory board for Vibrant Health which is formerly known as Wyandotte Community Health Center. He is also on the Board of Directors of Gamma Omicron, Inc. as the past treasurer. He has previously served as a member of the Kansas House of Representatives; the City of Leawood City Council; the City of Leawood Board of Zoning Appeals; the 2000 Johnson County Charter Commission as treasurer; the REACH Healthcare Foundation Board of Directors as chair and treasurer; the Overland Park Chamber of Commerce Board of Directors as the secretary and

treasurer; the Overland Park Chamber of Commerce Government Affairs Committee as a chair; the Greater Kansas City Chamber of Commerce Kansas State Affairs Committee as a chair; the Saint Luke's South Hospital Advisory Committee; the Johnson County Public Policy Council as a chair; the Johnson County Business Leadership Council; the Leawood Chamber of Commerce as a chair; the Johnson County Mental Health Governing Board as a chair; the Kansas, Inc. **B**rother Paul Wilbur, from West Bloomfield, MA, was initiated into Kappa Sigma in 1977. He graduated in 1980 with a B.S. in Business Administration as well as an MBA, with an emphasis in finance. After getting his MBA, he complet-



ed Executive Education activities at Michigan State University, MIT and Center for Creative Leadership.

Paul served as the Social Chairman of the fraternity in 1978 and as an alumnus he was a campaign volunteer and donor when we completed the major house renovation.

After graduating from KU's MBA program in December of 1981, Paul began to be heavily involved in the Automotive industry and holding multiple positions in numerous functional areas until excelling to the top of DaimlerChrysler in 2002. He decided to part with the automaker position and pursue a CEO role at a Tier 1 Automotive supplier and continue to advance his knowledge and experience from a supplier's perspective. He has received patents for engineering products, awards for new designs and internal awards at Chrysler and from outside third parties. He is proud to be a part of the five consecutive yearly awards won for Best Place to Work in Michigan at the Tweddle company.

Brother Wilbur is an active member on the Detroit area American Cancer Society, on the Cattle Baron's Ball Board of Directors, which raises over \$1 million per year for research support in finding the cure of cancer. He was very involved in the Gamma-Omicron Chapter and served as Treasurer for all four years. He stepped into the position as a freshman when the chapter was struggling financially and was able to put the chapter on the right financial path, with the help of other Grand Masters.

His involvement during his collegiate years were not only in Kappa Sigma but in other organizations on campus. While at the University of Kansas, he was a member of Phi Kappa Phi, an honor society, as well as a member of a business honor society, Beta Gamma Sigma.

Over the years, Davis has taken his leadership skills and knowledge from his degrees to four companies. He worked at Arthur Andersen as part of the Computer Audit Specialty Team, as a Business Systems Consultant, and as the Audit Division's Manager. Brother Bragolone received a Bachelor of Arts, honors program, 1984 from the University of Kansas. He also received his J.D., with honors, from the University of Texas School of Law in 1987, where he was a member of the National Moot Court team, the Benton Moot Court team, and was selected to the Order of Barristers.

While at the University of Kansas he was in Mortar Board honor society, Owl society, as well as Omicron Delta Kappa's National Honor Society. His involvement in honoraries played a large part in Brogalone's leadership and scholarly characteristics. He received the Chancellor's club scholarship in 1980. Through Kappa Sigma, he was awarded the Scholarship-Leadership Award.

In 1997, Jeff was a recipient of the "Most Outstanding Young Lawyer" Award for Dallas County. In 2000, D Magazine recognized Brogalone as " 40 Under 40" Best Lawyers and since 2006 he has been recognized as one of the "Best Lawyers in Dallas" by D Magazine, in both Business Litigation and Intellectual Property Litigation. Jeff was selected to Best Lawyers in America, 2016–2018, in Intellectual Property and Commercial Litigation and has been recognized as a Texas "Super Lawyer" for the past 15 years, from 2003 to 2018, as selected by Texas Monthly Magazine and Texas Law & Politics. Brother Brogalone is a founder of Bragalone Conroy PC in Dallas, Texas. Jeff has a nationwide complex commercial litigation practice, with an emphasis on patent and intellectual property litigation matters and technology related cases. His wide variety of experience has helped him with his professional success.

Jeff is President of the Board of Directors of the Dallas Theater Center, and has been a trustee of the Theater Center Board since 2012 and was privileged to take the stage at the 2017 Tony Awards Ceremony at Rockefeller Center in New York City, where the Dallas Theater Center was awarded the 2017 Regional Tony Award. Since 1988, Jeff has volunteered as part of the Dallas Bar Association's Bar None Production Company, which raises money for the Sarah T. Hughes Diversity Scholarships in Texas.
